STARTING YOUR FUND IS EASY

We will work with you to establish a fund naming the areas of interest you want to support. Once the details are discussed, it is as simple as signing a fund agreement and making your initial contribution. We prefer a \$10,000 minimum gift to open a Field of Interest Fund. You may use cash, stock, or other assets to create a named fund and qualify for an immediate income tax deduction.

You can choose to advise the Community Foundation on distributions from your fund through grant recommendations or relax and let our experienced staff and grant committees identify effective programs and projects operating in your chosen area of focus.
